- Make sure payment notation is on <u>every</u> receipt and matches what is on the 2nd tab of TRIP (example, paid by county, initial and date or paid by employee, initial and date)
- Do not click save and send for approval on TRIP until the last day of travel has passed. It will just delay the process of reimbursement.
- Employee must include an agenda if there is a registration fee paid or if claiming meals on overnight TRIPS.
