Tax Exemption & Volunteer Groups

Remember that agents cannot use UK's EIN/Tax Exemption. They must either use the Extension District Board's Tax Exempt number or Program Council Tax Exemption if they have 501c3 non-profit status. (Financial Guidelines for CES County Volunteer Groups – Tax Exemption Status Overview)

Each Extension entity will need to choose one of the four plans for handling funds described as Option A, Option B, Option C, or Option D.

County Program Councils and/or related entities may apply for tax exempt status as a 501(c)(3) organization. The councils/entities are a program of the Land Grant institution and will function through a Memorandum of Understanding with Kentucky Cooperative Extension Service.

There are at least two situations where it may be desirable for County Program Councils/entities to pursue 501(c)(3) tax exempt status:

- If the group conducts raffles, lotteries, or other forms of gaming as fund-raising activities.**
- If the group depends on grant funds that are awarded only to 501(c)(3) entities.**
- Have to be incorporated first (use a lawyer to set this up through the Secretary of State office)
 before applying for 501 c 3

Addition to Guidelines for Volunteer Groups – "A volunteer agreeing to serve as a treasurer for any Extension related group with peak bank account balances over \$500 must participate successfully participate in the Client Protection Risk Management approval process."

If practical, a bond or dishonest endorsement should be utilized to protect group assets.
