Emergency Closing

Covid Confidentiality

- Employees should refrain from sharing others' medical information (I.e., the medical information of volunteers, colleagues, community members, etc.) with anyone other than their supervisor or in response to an inquiry from UK Healthcorps or a local health department.
- If another person (i.e., an employee, volunteer, community member, etc.) needs to be informed of a possible COVID exposure, that will be handled by UK Healthcorps and/or the local health department. Their contact tracers determine when others need to be informed on a case-by-case basis, applying current medical knowledge of the disease, its spread and its infectious period.

Report to the People Update

- Changes to instructions are to allow more flexibility for counties.
 - Front picture option expanded to allow counties to include their own image; however, it must meet quality and resolution requirements. Counties still have the option to choose from the 20 suggested images provided.
 - Last page of document adapted with two options:
 - For counties that need more space to feature an additional program area, that is now allowed.
 - Smaller counties can continue to use the template containing state level data.

New Online Career Ladder Application

- Beginning in 2021, the application process for the career ladder will include an online submission.
- All requirements will remain the same, so agents who are planning to submit applications should begin preparing materials soon.
- The online application will be available in KERS by early January.
- Once submitted, an application must be approved by an Agent's Area Director and the appropriate Regional Director.
- Once approved by the Regional Director, the applications will be submitted to Program and Staff Development (by no later than February 1) to prepare for review and consideration for promotion.
